March 10th regular meeting of the District Commissioners adopt and recommend to the electors the district budget, including the general fund, the water fund and the electric fund. March 12th district budget, including the general fund, the water fund and the electric fund will be available to the public and March 17th is the electors' annual budget meeting. On St. Patrick's Day."
