Committee Chair Debora Goldstein called the Public Session of the meeting to order at 1:00 p.m. She requested roll call of attendance of those participating in person for the benefit of those participating by telephone. She identified members of the public also in attendance and asked that those participating by phone identify themselves. All telephone participants confirmed that they could hear and be heard.

Specific Action Item

(A) Public Comment

Chair Goldstein opened the floor for public comment. There was no public comment.

(B) Approval of the Minutes of the February 28, 2019 Special Meeting of the Special Committee

A motion was made by Committee Member Mark Oefinger, seconded by Committee Member Stewart Peil to approve the minutes of the February 28, 2019 Special Meeting of the Special Committee.

Motion passed unanimously.

(C) Executive Session

Chair Goldstein stated the reason for entering Executive Session is to discuss strategy and /or negotiations with respect to pending litigation regarding CMEEC's consideration of enforcement of legal relief or legal rights related to CMEEC employees.
